## Background

To help small family-managed business in Europe, the SFaB (Support Family Business) project, co-funded by the European Commission within the Erasmus Plus funding programme and actively driven by partner organisations in Greece, Spain, Bulgaria, Belgium, France and Austria introduced in our first newsletter, develops for company owners, managers and employees in family businesses a framework for learning and understanding the nature, importance, and uniqueness of family business helping to know how to improve the management of their business with little resources (money and/ or budget).

The five SFaB courses have already presented in our last newsletter. They are focused on:




FAMILY BUSINESS & SPECIAL CHARACTERISTIS, SUCCESSION,

In this free, self-paced online course, you will learn theoretical and practical knowledge regarding the following topics:




The SFaB course has been developed by the University of Aegean with the contribution of all project partners and is available in six languages; English, French, German, Bulgarian, Spanish and Greek. It is divided into five modules, and each module includes, apart from the theory, practical examples and audiovisual material. Upon completion of the course having answered the multiple choice questions, the learners can receive a certification of completion.





### Our SFaB Virtual Learning Environment (VLE)

Our Greek project partner ReadLab, supported by our Belgian project partner Candide International (specifications of VLE), has built the technical backend and opened the platform access with the training programme, our MOOC.



How you can enter

The registration is simple: just go to <a href="https://training.sfab-project.eu/">https://training.sfab-project.eu/</a> and register with your details. You will then receive access to the other parts of the VLE. The navigation is easy and self-explanatory helping you to enter the individual features the VLE offers.



A Toolkit that shall present successful examples, good practices and theory on valid and high-grade knowledge within these topics.

The toolkit is intended to be used as a guide for family-run business, in particular by their owners, employees, managers and other staff attending the MOOC to help learn also from good practices found in the partner countries. These examples shall highlight solutions related to questions one might have when preparing a succession, on emergency plans, stereotypes, communication in family business and many other aspects.

It also includes short summaries on the partner countries that help better understand the importance and an overview of family businesses today (highlighting the number of businesses in the country, their contribution to the national GDP, their average size of family businesses, etc.).



## Our third project meeting

Building a project partnership with the widest-possible geographic reach has been one objective when planning the SFaB project. The core organisations bring together Southern Europe - Greece, East - Bulgaria, Central - Austria and Belgium, as well as from West Europe - France and Spain.
